Sir/Madam,

The undersigned is directed to inform that Dte. GHS intends to auction scrap items available in the store of this Directorate (7th Floor, Nirman Bhawan). These items include metal scrap, plastic scrap, glass scrap, paper scrap, tyre scrap, wire scrap and other miscellaneous scrap accumulated over the time.

2. The willing scrap dealers may visit the store and may see the scrap and submit the sealed quotations mentioning rates @ per kg alongwith the other details (name of the firm, address, mobile number, TAN/PAN/GST). The sealed quotations shall be dropped in the tender box kept in Gen. Section within 7 days (till 31.07.2024). The tender box shall be opened on 01.08.2024 at 3:00 PM in room no. 342-A-II. Your offer validity will be till 15.08.2024. Any quotation received after 31.07.2024 shall not be accepted by the Committee.

3. The weight of the scrap shall be weighed on the Dharamkata and on the basis of the receipt of weight of scrap so weighed, Cheque/Demand Draft/Cash of the corresponding amount shall be submitted by the highest bidder immediately after the weight of the scrap is done.

4. Note: The quotations received from any other scrap dealer(s) (other than the addressee dealers) will also be accepted.

5. The highest bidder shall have to collect the scarp at their cost (including all cost of labour, loading, unloading etc.) within 7 days after award of letter failing which their right to collect the scrap will be forfeited and may be blacklisted for future tendering in Govt. Departments.


