
On attaining the age of 62 years Dr. BD Athani is hereby posted in Dte.GHS as Principal Consultant w.e.f. 02.04.2018. The work allocation henceforth till he attains the age of superannuation, shall be as under:-

- (i) Medical Education matters relating to VMMC, LHMC, KSCH, PGIMER, AIIMS, PMSSY, New Capacity building scheme of ME. In order to maintain continuity, work related to Medical Counselling shall also be looked after during the current academic year only.
- (ii) ME matters relating to JIPMER, NEIGRIMS, RIPANS, RIMS, NIMHANS, AIIPMR (Mumbai).
- (iii) Matters relating upgradation of District Hospitals and Medical Colleges as the Chairman of the STC.
- (iv) E-curriculum, various councils, Bachelor of Rural Health Care, AIIH&PH, Kolkata.
- (v) In addition to above, Dr. BD Athani shall also be providing clinical services in OPD in Paediatric, Orthopaedic and Rehabilitation (PMR) Department of Safdarjung Hospital, New Delhi.

4. All residual items of work in Dte.GHS not expressly allocated to DGHS / Principal Consultant / Principal Advisor, will be looked-after by Officer-in-charge DGHS.
